Η Μαρία Κυριακού είναι Αναπληρώτρια Καθηγήτρια στο Διεθνές Πανεπιστήμιο της Ελλάδος, Πανεπιστημιούπολη Σερρών. Κατέχει μεταδιδακτορική έρευνα και διδακτορικό από τη Σχολή Κοινωνικών Επιστημών του Ελληνικού Ανοικτού Πανεπιστημίου και δύο μεταπτυχιακά διπλώματα εκ των οποίων το πρώτο από το τμήμα της Εφαρμοσμένης Πληροφορικής του Πανεπιστημίου Μακεδονίας με εξειδίκευση στην Επιχειρηματική Πληροφορική και το δεύτερο από τη Σχολή Κοινωνικών Επιστημών του Ελληνικού Ανοικτού Πανεπιστημίου με ειδίκευση στη Τραπεζική. Είναι απόφοιτη του τμήματος Διεθνών Οικονομικών Σχέσεων και Ανάπτυξης του Δημοκρίτειου Πανεπιστημίου Θράκης. Άρθρα της έχουν δημοσιευτεί σε διεθνή συνέδρια και σε επιστημονικά περιοδικά διεθνούς κύρους και έχει διδάξει σε πάνω από πέντε Πανεπιστήμια ημεδαπής και αλλοδαπής τόσο σε προπτυχιακό όσο και σε μεταπτυχιακό επίπεδο. Τα ερευνητικά της ενδιαφέροντα εστιάζονται στον τομέα της Ελεγκτικής, της Εταιρικής Διακυβέρνησης, της Λογιστικής, των Διεθνών Λογιστικών Προτύπων και των Χρηματοοικονομικών Αγορών προσδιορίζοντας τις διαφορές μεταξύ των χωρών σε Λογιστικά και Χρηματοοικονομικά Πρότυπα. Στο παρελθόν έχει εργαστεί στον ιδιωτικό τομέα για αρκετό χρονικό διάστημα αποκτώντας επαγγελματική εμπειρία στον Τραπεζικό και Βιομηχανικό χώρο, μεταξύ άλλων θέσεων, κυρίως ως Λογίστρια και Οικονομολόγος. Είναι κριτής σε έγκριτα διεθνή επιστημονικά περιοδικά και επιβλέποντα σε διδακτορικές διατριβές καθώς επίσης επιβλέπει πτυχιακές και διπλωματικές εργασίες.
